ORDER

The Director, Indian System of Medicines has forwarded a proposal of temporary promotion of Last Grade Employees to vacant post of Attender Grade II/Nursing Assistant Grade II/Pharmacy Attender Grade II vide letter read as second paper above. The qualification for the post of Attender Grade II/Nursing Assistant Grade II/Pharmacy Attender Grade II vide Government Order read as first paper above are i). Pass in Std.VII or equivalent qualification, ii) Pass in Attender test conducted by the Public Service Commission; those who have passed S.S.L.C and have completed 3 year service in the department need not pass Attender's Test. There are 332 vacant posts in Ayurveda Dispensaries in the Department and these posts are to be filled up amending the Special rules. The ISM Director has reported that due to administrative exigency, the above posts are to be filled up on a temporary basis.

Government have examined the matter in detail and are pleased to accord sanction to Director Indian System of Medicines to fill up the 332 vacant posts of Attender Grade II/ Nursing Assistant Grade II/Pharmacy Attender Grade II on temporary basis from the list of Last Grade Employees on the basis of seniority in relaxation to existing rules, on condition that they will be reverted as and when qualified hands are available as per Special Rules.
