ORDER

In the Government Order read as 7<sup>th</sup> paper above, Government have modified the O.P. timings of the peripheral health institutions viz., CHCs, PHCs and Dispensaries under Health Services Department as 9.00 am to 1 pm and 2.00 pm to 3 pm.

2) In order to have uniformity in O.P. timings of all Hospitals/health Centres/Dispensaries in Allopathy, Ayurveda and Homoeo streams Government have decided to extend the O.P. timings viz., 9.00 am to 1.00 pm and 2.00 pm to 3.00 pm to all Hospitals/ Dispensaries under the control of Directorate of Indian Systems of Medicine and Directorate of Homoeopathy also.

3) Therefore, Government hereby modify the Government Order read as seventh paper above and order that the O.P. timings of all the Community Health Centres, Primary Health Centres, Block Primary Health Centres and Dispensaries of Health Services Department and Hospitals under Directorate of Indian Systems of Medicine and Directorate of Homoeopathy will be fixed as 9.00 am to 1.00 pm and 2.00 pm to 3.00 pm. Doctors are expected to be physically present in institutions concerned during this time to take care of patients.

4) In institutions with a single Medical Officer, field activities should be planned in advance as part of the Block PHC Monthly Action Plan. The O.P. timings and field activity schedule should be exhibited in the institutions for avoiding inconvenience to the patients. The Medical Officers and Para Medical Staff should ensure strict adherence to these timings to ensure better services to public at large.

5) The Government Order read as 7<sup>th</sup> paper above stands modified to the above extent.
