- 5) The land shall be resumed by Government without payment of any compensation in case the Municipality fails to abide by all or any of the aforesaid conditions.
- 6) The Municipality will demolish and reconstruct the compound wall at their own cost.

2. The District Collector, Ernakulam will take necessary steps to implement this order and to affect necessary changes in the Revenue records on time.


