O R D E R

At present Vaidyaratnam P.S. Varier, Ayurveda College Kottakkal does not have a hospital of its own for clinical training of the BAMS students of the College. The annual admission capacity of the College is 30 and as per the norms prescribed by the CCIM, the College should have the minimum hospital facility with 90 beds. 42 beds out of the 114 beds in the charitable Hospital of the Arya Vaidyasala, Kottakkal have already been set apart exclusively for clinical studies and admission to these beds are made by teachers of the College. The University of Calicut has been insisting to provide a separate hospital for the College.

In the letter read as first paper above, the University have conveyed the decision of the Syndicate to revoke the earlier decision of the University to suspend the Affiliation for 1 year BAMS course the academic year 1987-88 subject to certain conditions. One of the conditions is that 48 more beds should be provided before the commencement of the course during the academic year 1987-88.

Government have examined the matter in detail and explored the possibilities for starting the hospital temporarily in the ground floor of the college building, the teaching departments being arrange in the first floor. It was also examined whether the hospital may started by the Department of Indian Systems of Medicine and may be utilised for the Ayurveda College, till new hospital building is constructed.

In the letter read as second paper above, the Director Indian Systems of Medicine has forwarded proposals for starting the hospitals. At present there is no District Ayurveda Hospital for Malappuram District. But there is a 10 bedded hospital at a distance of about 7 kms. from the Ayurveda College, Kottakkal. The Director Indian-Systems of Medicine has proposed that these 10 beds may be shifted to the College building and 40 more beds with necessary <sup>POOK</sup> sanctioned. After having examined all the aspects in detail. Government are pleased to issue the following orders.

- (i) A District Hospital under the Director of Indian Systems of Medicine, for the Malappuram District with 50 beds will start functioning in the ground floor of the Vaidyaratnam P.S. Varier Ayurveda College Kottakkal till a new hospital building is constructed.

- (ii) The 10 beds available in the hospital at Kottakkal will be shifted to the new hospital.
- (iii) The O.P. Section and dispensary will continue to function in the existing hospital building.
- (iv) The furniture, bedding and clothing worth of Rs.1,78,000/- Rupees One lakh seventy eight thousand only will be provided by the parent-teachers Association of the College as agreed to.
